3.0 Uploading of bidding documents shall not automatically construe that the bidder/agency fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents submitted by the bidder/agency. Bid documents are not transferrable.

4.0 The purpose of the pre-bid meeting will be to clarify the scope of work, and any issues regarding the bidding documents and the Technical Specifications, if raised at that stage by the bidder/agencies. The WBSETCL shall not be under any obligation to entertain /respond to suggestions made or to incorporate modifications sought for by the bidder/agencies during the pre-bid meeting or thereafter.

5.0 **The bidders may quote against any single Group (Group-A or Group- B) or Both the Groups (Group A and Group B). Bidders have to quote service charge for Group-A and for Group- B bidders must quote service charge for General, Tatkal quota and Premium Tatkal under both A/C & Non A/C categories. If the rates for Normal, Tatkal Quota & Premium Tatkal Quota for A/C & Non A/C categories are not quoted by the bidder, the price bid of that bidder will be rejected.**

6.0 All bids shall remain valid up to a minimum period of **one hundred and twenty (120) days** from the next day of **price bid opening date**.

7.0 All bids must be supported by EMD / **bid security** for an amount of

a) For Group-A: Rs.10000.00 [Rupees Ten Thousand Only]

b) For Group-B: Rs. 1300.00 [Rupees One Thousand three hundred Only]

in the form of Demand Draft /Pay order / Banker's Cheque drawn **in favour of West Bengal State Electricity Transmission Company Limited** from any scheduled **Commercial Bank, Payable at Kolkata**. Bidders must submit the Bid security physically within the stipulated date as above at the office of the **General Manager (HR&A), 8th Floor, D-Block, Bidyut Bhawan, Saltlake, Kolkata-91** and also to be documented along with the bid and submitted online. Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non responsive.

Against offer bid for more than one Group (for both the groups), the bid security amount shall be the sum of the respective individual Group bid security amount of the offered items as specified above.

8.0 Qualification Requirement for Bidder/Agency:

8.1. Following shall be the qualification requirement:

Technical:

1. Bidder/ Agency should have a membership with International Air Transport Association [IATA] for Air Ticket and Indian Railway Catering and Tourism Corporation Ltd [IRCTC] for Rail Ticket.
2. Bidder/ Agency should have served at least 1 Govt/PSU's/Reputed Company's for the completed 1 years within last 5 years from the date of issuance of this tender notice in providing travel related services for each Group.
3. The Bidder/ Agency must have their own office at Kolkata to carry out day to day functioning.

Financial:

i. Liquid Assets (L.A) as per the last audited accounts available should be as follows

a) For Group-A: Rs.83,333/- [Rupees Eighty three thousand three hundred thirty three]

b) For Group-B: Rs. 10,833.00 [Rupees Ten Thousand Eight hundred thirty three only]

Bidder/ Agency shall have Liquid Asset (L.A) and/ or evidence of access to or availability of credit facility of equivalent amount.

Against offer bid for more than one Group (for both the Groups), the L.A amount shall be the sum of the respective individual Group L.A amount of the offered items as specified above.

ii. Minimum Average Annual Turnover (MAAT) for best three (03) years out of the last five (05) financial years excluding non-recurring item should be as follows:

a) For Group-A: Rs.5,00,000.00 [Rupees Five Lacs only]

b) For Group-B: Rs. 65,000.00 [Rupees Sixty five thousand only]

Against offer bid for more than one Group (for both the Groups), the MAAT amount shall be the sum of the respective individual Group MAAT amount of the offered items as specified above.

iii. Net Worth should be positive.

8.2. **The bidder/agency shall upload**, as part of his techno-commercial bid, documents establishing the bidder/agency's qualifications to execute the Order to the satisfaction of the WBSETCL. All documents required to establish bidder/agency's financial and technical qualification must be submitted as part of techno-commercial bid. In particular, the following documents need to be uploaded by the bidder/agency:-

- a. Copy of valid membership with International Air Transport Association [IATA] for Group A { Air Ticket} and Indian Railway Catering and Tourism Corporation Ltd [IRCTC] for Group B{ Rail Ticket}.**[Applicability up to the extent of meeting Technical QR]**.
- b. Copies of work order of few Major reputed organisations/department of Government of India/ public Sector Undertakings/ Statutory bodies/ MNC wherein travel related service has been executed during completed 1 years within last 5 years from the date of issuance of this tender notice supported by documentary evidence for each Group.**[Applicability up to the extent of meeting Technical QR]**.
- c. Documentary evidence of executing travel related services covering all the aspects as well as satisfactory completion / on-going certificate stating the Annual value of work from the client for each Group.**[Applicability up to the extent of meeting Technical QR]**.
- d. Audited Annual Accounts of the company for the last Five (5) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last Five (5) years (in case of bidder/Agency other than companies).**[Applicability up to the extent of meeting Financial QR]**.

- e. Self-declaration that the bidder/agency should not have been debarred or blacklisted by any State or central govt/ PSU in India while executing similar nature of work. If any dispute is pending at any Court of Law or under any Arbitration/ similar process pending decision of debarring/ blacklisting, detailed information must be enclosed.

The Bidder/agency who have been delisted or debarred or Blacklisted by any State or Central Government/ PSU in India while executing similar nature of work shall not be eligible any way.

- f. Copies of Income tax/ Professional Tax Clearance Certificate / P.T (Deposit Challan)/ PAN card / GST Registration Certificate.
- g. Registered Deed of partnership Firm / Article of Association & Memorandum/ Certificate of incorporation in India etc.
- h. Documents to provide evidence that Registered office/Service Centre of the bidder/agency is within Kolkata jurisdiction.

8.3. In addition to above, the bidder/agency shall also be required to meet the eligibility conditions and upload a scanned & digitally signed copy of Power of Attorney in favour of Signatory of the Bid as per Annexure: 4 & an Affidavit regarding Eligibility (duly notarized) as per Annexure: 6 of Section V-A of the bidding documents.

N.B.: The Original Power of Attorney in favour of Signatory of the Bid as per Annexure: 4, an Affidavit regarding Eligibility (duly notarized) as per Annexure: 6 of Section V-A of the bidding documents shall be submitted physically to the Office of The General Manager(HR&A), WBSETCL under sealed cover on or before the scheduled date & time as specified above.
