- i) Tower Earthing Complete: Pipe Earthing/Counter-poise earthing with supply of GI pipe, GI flat, GSS earth wire charcoal, salt and all other materials as required for completion of the work i.r.o Purulia-Bagmundi 132KV D/C Transmission Line under jurisdiction of Purulia Line Tr (O&M) Sub Division under Purulia Area Office, WBSETCL (Total 82 Nos Tower), at Purulia District.

- 4.0 Downloading the bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder
- 5.0 All bids must be supported by Bid Security (EMD) for an amount of Rs. 7,652.00 (Rupees Seven Thousand Six Hundred & Fifty Two Only) in the form of Demand Draft / Pay Order / Banker's Cheque drawn in favour of **"PURULIA AREA OFFICE WBSETCL"** from any scheduled commercial bank, Payable at Purulia. Bidders must submit the Bid security physically within the stipulated date as above at the office of

the S.E. & Area Manager, P.A.O., within the date as specified above and also to be documented along with the bid and submitted online. Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non-responsive.

6.0 Qualifying Requirements (QR) for bidders:

6.1. Following shall be the qualification requirements:

A) Technical QR(TQR):

- I. The bidder must have completion report of previous executed value at best 60% of cost estimate i.e. Rs. 4,59,139/-
- II. The bidder must have sound work experience for execution the work of counter poise/ pipe earthing to minimize the TFR up to the mark.

B) Financial: Financial Q.R.(FQR) for the tender are as follows:

Net Worth:	Net Worth should be positive.
Liquid Asset:	Rs. 7.65 Lakhs. Bidder should have liquid assets (L.A) and/or evidence of access to or availability of credit facilities of equivalent amount.
MAAT:	Rs. 11.47 Lakhs.
EMD:	Rs. 7,652.00

NB: 1. MAAT: Minimum average annual turnover for the best three years out of the last five financial years.

2. 'Liquid Asset' shall be as per the last audited accounts available.

6.2. The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
- b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies).

c. Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.

6.3. In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per **Annexure: 5 of Section VI-A** of the bidding documents.

6.4. Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services.

7.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
